3 Exhibition Options:

1. **'Rumstick Point' - \$75.00 Booth Fee (\$65.00 for Barrington Residents)** Prime real estate near the front of the Town Hall/Library. Tents & tables are both required to exhibit here. Tables should be 8 feet long and covered with a cloth to the ground.
2. **'Shady Way' - \$50.00 Table Fee (\$40.00 for Barrington Residents)** Secondary real estate in the shade behind the Town Hall. Tents are optional however you must have a table to exhibit here. Tables should be 8 feet long and covered with a cloth to the ground.
3. **'Beach Drive' - \$35.00 Space Fee (\$25.00 for Barrington Residents)** Enjoy the fun in the sun! Bring a beach umbrella and a table or easel to exhibit here.

Along with the application, please **provide two images** (jpeg format) representing the body of work to be exhibited. Images should be submitted to cvillucci@barrington.ri.gov with your name clearly marked. Please provide file names for each image, including the name of the artist and title of the artwork.

If not accepted, your exhibit fee check will be returned to you by mail.

Exhibitor agrees to the following: Exhibited art work is restricted to work representative of that which is submitted for acceptance. All artwork offered for sale must be the creation of the exhibitor. Buy/sell is strictly prohibited. Booth sharing and subletting prohibited.

No packing until the conclusion of the show. (5:00pm)

Management reserves the right to decline, prohibit or expel any artist which in its judgement is not in keeping with the character of the exhibition.

Tax: RI Sales Tax Permit Number. There is no sales tax for artists but a permit is required. Temporary permits are available upon request. They can be filled out the day of the Festival. The permit forms are from the RI Division of Taxation, One Capital Hill, Providence, RI 02908. We have several in the Recreation Department Office.
