No packing until the conclusion of the show. (5pm)

Management reserves the right to decline, prohibit, or expel any artist which in its judgement is not in keeping with the character of the exhibition.

Tax: RI Sales Tax Permit Number. There is no sales tax for artists but a permit is required. Temporary permits are available upon request. They can be filled out the day of the Festival.
