

**PUBLIC NOTICE

GENERAL ELECTION  
ON TUESDAY, NOVEMBER 8, 2022**

**TOWN OF BARRINGTON, RHODE ISLAND**

You are hereby required to warn the electors of Barrington, entitled to vote in Senatorial District 32, Representative Districts 66 and 67, Precincts 101–Barrington High School, 102–Barrington Middle School, 103–Nayatt School, 104–Hampden Meadows School, 105–Sowams School, and 106–Barrington Town Hall to assemble in Town on Tuesday, the 8<sup>th</sup> day of November, A.D. 2022 at 7 o'clock in the forenoon for the purpose of:

1. Casting their ballots for a Representative in Congress of the United States for the First District for two years;
2. Casting their ballots for a Governor, Lieutenant Governor, Secretary of State, Attorney General, General Treasurer of the State of Rhode Island for four years;
3. Casting their ballots for One Senator and One Representative from each District from Barrington to the General Assembly for two years from January 2023;
4. Casting their ballots for Town Officers for the Town of Barrington, as follows: A Moderator for two years, Two Council Persons for four years from November 2022 and Two School Committee Members for four years from November 2022

ALSO,

To vote to approve or reject the following three (3) State of Rhode Island bond questions (Chapter 231 – Public Laws 2022):

1. University of Rhode Island Narragansett Bay Campus - \$100,000,000;
2. Rhode Island School Buildings - \$250,000,000; and
3. Green Economy Bonds - \$50,000,000

ALSO,

To vote to approve or reject the following one (1) local question in the Town of Barrington:

4. RI CANNABIS ACT: STATE ISSUED LICENSES (Sec.21-28.11-15(a) and (b) Cannabis Act) (Resolution of Town Council adopted June 6, 2022).

Shall new cannabis related licenses for businesses involved in the cultivation, manufacture, laboratory testing and for the retail sale of adult recreational use cannabis be issued in the Town of Barrington?

and to transact such other business as shall legally come before them by posting up written notification in a public place in said Barrington in Senatorial District 32, Representative District 66 and 67, Precincts 101–Barrington High School, 102–Barrington Middle School, 103–Nayatt School, 104–Hampden Meadows School, 105–Sowams School, and 106–Barrington Town Hall the time when and the place where said meeting is to be holden and the business to be transacted therein. Said notification to be posted as aforesaid at least seven (7) days before the day appointed for said meeting.
